- B. Approval of October and November 2013 Check Register: Motion made by Chris Eggleton to approve the October 2013 Check Register. Seconded by B. Todd Hopkinson. All voted yes, motion carried.

The District experienced in 2013 the customer growth of 79 new customers hook ups from stand by fees to current water customers. The number of Promontory Assessments has been higher than projections for 2013. Revenue is 5.3% above the approved 2013 Budget. Water Sales 1% under budget with the rain in the summer and fall.

Expenditures are under budget because of power costs savings. Interest expenses are under budget for 2013. Cash balances have increased by about a million dollars from last year this will allow us to meet the District's goal of having 120 days of cash revenue on hand at all times. April and May this year we meet our goal for 120 days of cash on hand to meet the goal the Administrative Control Board set for the CFO. Capital budget was under budget in 2013. Green Projects are under budget and Mountain Regional Water Special Service District billed the state \$60,000 for labor costs to reimburse MRWSSD for staffing costs. Summit Park Phase 3 project came in under budget also. We are doing well in every category. We borrowed a \$500,000 dollars for our Emergency Fund from Summit County and paid it off a year early this year. Motion made by Chris Eggleton to approve the November 2013 Check Register. A. New Development Update: The update on Plat I in Silver Creek Estates, Woodside homes is the developer for Plat I in Silver Creek Estates. Mountain Regional Water Special Service District by annexing and serving water to Woodside Homes allows MRWSSD to have a water line in front of the Bitner property the north side of I 80. This is the property that Summit County has expressed interest in placing affordable homes in clusters. Mountain Regional Water Special Service District will have a water supply close and hopefully be a water provider for that property.

Jim Doinley came in to meet with Andy Armstrong. He has about 80 ERC's that are prepaid impact fees.

They do not want to serve Plat I the Woodside development. They did not plan on serving that area for water service. The Woodside development has 66 residential connections. Todd Hopkinson to approve the Agreement for the Exchange of Water in Emergencies between Mountain Regional

Water Special Service District and Summit County Service Area # 3. Seconded by Chris Eggleton. All voted yes, motion carried.
