- 7. General Manager Update: Andy Armstrong reported that the Awwa Conference was excellent and he had a great meeting with Tage Flint the General Manager for Weber Basin Water Conservancy District. Andy Armstrong was encouraged that Tage will be more responsive to MRW requests for information and project updates. They discussed the water intake in the Rockport State Park and they are not sure how to fix the freezing problem. A long term solution would be the intake would be located in the reservoir and will be an expensive project in the long term water importation project. This would require a new water intake and duel pipelines. Andy Armstrong would like to discuss MRW Board Goals next meeting. He suggested the Impact Fee, Capital Facilities Plan, Strategic Plan, Long term financial planning and transition planning be discussed in the 2018 Goals.
 Andy Armstrong also discussed the need for a Summit County Council work session on

MRW District Goals early in 2018.
